In accordance with Massachusetts General Laws Chapter 82, Section 32, the following report or return is transmitted to the Town Clerk of the Town of Chelmsford, We, the undersigned, Selectmen of Chelmsford in Said County of Middlesex upon petition of the Selectmen of Chelmsford for the Laying out of **Hall Road** having first given notice as required by law, to the owners of the several lands over which said way is to be laid out and having met at the Town Office in that part of Chelmsford known as Chelmsford Center on the **25<sup>th</sup> of March, 2019** and having previously examined the premises and having heard all the parties at said meeting who desired to be heard, declared that public necessity and convenience required the aforesaid way to be laid out and the fee in the land be taken as a public way, and such laying out having been filed in the office of the Town Clerk and accepted at Town Meeting on **April 29, 2019**, do hereby make our report or return to the Town Clerk of Chelmsford that said way has been taken as a public way as follows:

## Hall Road

The owners of the several lots of land over which this way is laid out are allowed ten days after the acceptance thereof by said Town of Chelmsford to remove there from any wood, timber, trees, walls, fences, and other property which may obstruct the building of said way.

And the Selectmen after hearing the owners of said several lots of land either by themselves or their agents relative to the assessments of land damages by them sustained in consequence of such laying out, do hereby upon consideration thereof, determine that no such damages are assessed, and no such damages should be allowed.
