INSTRUCTIONS:

- Town-wide candidates (incumbents and challengers) must obtain a minimum of 50 signatures from registered voters. The Clerk strongly recommends all candidates **obtain additional signatures**.
- Non-incumbent Town Meeting Representative candidates must obtain 25 signatures of registered voters from the precinct they wish to represent. The Clerk strongly recommends all candidates **obtain additional signatures**.
- Town-wide candidates are entitled to eight (8) blank nomination papers. Town Meeting Representative Candidates are entitled to four (4) blank nomination papers.
- Town-wide candidates must remember the following Campaign & Political Finance obligations:
 1. Before incurring any expenses or receiving any funds they must file a **Statement of Organization**.

 2. **Your first OCPF (Office of Campaign and Political Finance) report is due on Monday March 30, 2020 - eight (8) days before the election.**

 3. **Your second OCPF report is due on Thursday, May 7, 2020 - thirty (30) days after the election.**

 4. **Even if you incur no expenses and raise no money**, you are still obligated to sign the CPF M 102-0 report in the Office of the Town Clerk, both eight days before and thirty days after the election.

Please be aware that you have an obligation to file
all necessary paperwork with the Clerk's Office.
