As you know, today Governor Baker signed into law changes to Chapter 5 of the Acts of 2021 extending the provisions of Chapter 255 of the Acts of 2020 until June 30, 2021. In accordance with subsection (l) which provides for a local option for in-person early voting, I am writing to request and recommend in-person early voting for the April 6, 2021 local election. Please accept the following motion for the Select Board's consideration.

I move that the Town Clerk shall conduct in-person Early Voting in accordance with Chapter 5 of the Acts of 2021 and that Early Voting shall take place at the Town Offices at 50 Billerica Road on the following dates & times:

Saturday, March 27 - 9:00 AM - 1:00 PM

Monday, March 29 – 8:30 AM – 4:00 PM

Tuesday, March 30 – 8:30 AM – 7:00 PM

Wednesday, March 31– 8:30 AM – 4:00 PM

Thursday April 1 – 8:30 AM – 4:00 PM

Friday, April 2 – 8:30 AM – 1:00 PM
