Dear Members of the Selectboard:

Attached is a revised list of recommended candidates for appointment as election workers for the upcoming annual appointment period.

In accordance with Massachusetts General Laws, Chapter 54, Section 12: “*The selectmen of every town shall annually, not earlier than July fifteenth nor later than August fifteenth, appoint as election officers for each voting place or precinct...*” the appropriate number of election workers necessary to conduct elections in the Town.

Additionally, Chapter 54, Section 13 states: “*...every election officer shall hold office for one year, beginning with September first succeeding his appointment, and until his successor is qualified, or until his removal...*”

The attached list of recommended election worker candidates generally mirrors the party proportions of the Town’s registered voters. The list was updated due to some changes in party affiliation, and the addition and deletion of a few election workers since the original list was printed. The table below details the election worker’s party affiliation and the total number of registered voters in each corresponding party in the Town of Chelmsford as 12/31/2021.
